1. Approve Minutes of 3/5 Tim Slowinski moved to approve the Minutes of 3/5. Barbara Griffin seconded. Passed unanimously.

2. Health Agent Updates:

#### Housing Issues:

a. 160-162 S. Green River Rd. [septic & housing violation updates, if any] **No update. Randy will reach out to Shawn.** 

### Title 5/septics:

- a. 107 Adamsville Rd. [update from condemnation]. Condemned per vote of BOH at meeting on March 5<sup>th</sup>.
- b. 48 Call Rd [Title 5 failed-repair due by 3/7/2025]. On hold. Still has until 3/7/2025 to replace septic.
- c. 269 Heath Rd. [Letter to be sent]. To be sent.
- d. 116 Main Rd [Notice of Noncompliance sent; update, if any]. This is an old sale. Looking at a potential housing situation.
- e. 12 Wilson Hill Rd. [septic done, waiting on final inspection]. **Certificate of Compliance has been issued.**

#### Debris/Trash/Misc:

- f. 341 Adamsville Rd [update if available]. Follow up letter to be sent.
- g. 22 Heath Rd [Update on violations and Order to Correct]. A letter was sent and a follow up one is coming.
- 3. Health District Update-CPHS oversight meeting.
  - Meg Ryan is doing lots of work on age & dementia work.
  - Local Public Health Institute is gone, and the Foundations Course is now through TRAIN.
  - CHIP [Community Health Improvement Program] is offering Serv Safe programs as well as CPR & First Aid. Grants available. See attached flyer.
  - Nina mentioned that she is working with Meg Ryan on community health prevention and promotion classes.
  - Septic regulations will be drafted by CPHS and Colrain will hold a hearing at a future meeting.
  - Tobacco regulations>CPHS is looking for a cap of stores allowed to sell tobacco products before the final draft and advertisement of hearing. Barbara Griffin moved to allow 2 businesses to retail tobacco. Tim Slowinski seconded. Passed unanimously.

- 4. Incident command system (used by fire and police for emergencies) BOH members required to be trained. Tabletop training is happening soon for CPHS towns.
