and water shield is nearly applied. He mentioned there was some water damage due to heavy rain on Sunday, which will be repaired by the contractor. He anticipated three

Fire Chief Nick Anzuoni spoke with the Board regarding an opportunity to obtain a surplus 1995 Jeep Cherokee from the Department of Justice. The vehicle is located currently in PA and members of the fire department will pick it up. There is no cost to the town for the acquisition, although insurance and maintenance are the responsibility of the town.
