Full-Time Police Officer Appointment:

Kevin prepared an offer letter for the Boards approval. The offer stated that while Mr. Hunkler is attending the police academy he will receive a pay rate of \$17.34 per hour and once he has completed the academy his pay rate will increase to \$18.34 per hour. The Academy starts on October 15, 2018 and ends on April 12, 2019. Chief Lannon attended the meeting and explained his budget and how he intends to pay for the new officer's salary while he is at the academy. He also explained that he did some calculations and that it would be less expensive for the officer to use his own vehicle and be reimbursed mileage. Kevin suggested that the officer provide the Town with a copy of his motor vehicle insurance policy.

Approval of State Election Warrant:

Kevin had a request from the Connecticut River Conservatory to use the Highway Department's meeting room on October 2nd and October 4th. The Board approved the use.

Review of the Proposed Host Agreement between the Town and Atlantic Canabus:
