### **MINUTES OF February 22, 2022**

The meeting was called to order by Joe Kurland, Chair, at 4:30 p.m.

Appointments Jonathan Lagreze - Representing the Friends of Spruce It Up Colrain/Earth Day 22: 1) request for support for a used tire collection drive utilizing the town transfer station 2) request for a temporary suspension of the posted \$5 per tire for disposal 3) request for a new \$3 per tire disposal charge 4) request for the use of the town's Highway Dept. payloader, and 5) request for consideration of imprimatur to a wider "Spruce It Up Colrain/Earth Day 22" event. Mr. Lagreze presented an overview of the goals of the "Spruce It Up, Colrain!" campaign as a longtime town representative of the Franklin County Solid Waste Management District, and is

> Mr. Lagreze has volunteers to help with the event so as not to burden town employees, but the town will take ultimate responsibility for DEP compliance and permitting, as well as overages of disposal costs. He will need a loader and someone to operate it. It's Mr. Lagreze's opinion that the town has a surplus in the budget to pay for an employee(s) to work for this campaign. These funds can also allow the town to adjust its fees; for example, tires could be reimbursed at the town's cost of \$3 per tire instead of the current \$5 fee.

Regarding the hundreds of tires at Flower Xpress's building site at Shearer's farm and on Heath Rd, Mr. Slowinski suggested putting the dumpster where the tire collections are instead of at the Transfer Station.

Mr. Slowinski asked about donations made by Flower Xpress for tire removal. Flower Xpress and the Town of Colrain are in negotiations for a Host Community Agreement; therefore, the town cannot receive donations from Flower Xpress. Mr. Lagreze insisted that there are a number of funders who all want to remain anonymous and that the Friends of the Library have agreed to handle the donations. Chair Kurland noted this activity could be seen as Flower Express trying to influence the outcome of the negotiations by a donation, and would like to hear from the town's attorney on the matter.

Highway Superintendent Scott Sullivan joined the meeting to discuss the logistics of using the Transfer Station. The Select Board asked that Johnathan and Scott Sullivan meet to work out a plan for a higher volume of tires, trash and bulky waste, while keeping residents and volunteers safe, and bring that plan to the next Select Board meeting.

Landscaping this spring on the town common is premature. The warranty on the work done will be void if there is foot traffic during this time.

The Select Board gives their approval for the general idea of "Spruce It Up, Colrain."
