Chair Ben Eastman called the meeting to order at 4:32 pm.

Tax Classification Hearing Per M.G.L. Chapter 40 Section 56

Ben Eastman opened the hearing in accordance with M.G.L. Chapter 40 Section 56 at 4:33 pm.

Kevin Fox informed the Board that the hearing was advertised on 10/24/2023 in the Greenfield Recorder and the purpose of the hearing is to decide on a single or split tax rate.

MOVED: Thom Griffin moved to adopt a single tax rate for FY2024.

New Business: Requests to be Appointed to Energy Committee: David Greenberg, Chris Krezmien

Kevin Fox informed the Board that both David Greenberg and Chris Krezmien sent emails requesting to be appointed to the Energy Committee. There are currently five vacancies.

MOVED: Thom Griffin moved to appoint David Greenberg to the Energy Committee and appoint Chris Krezmien to the Energy Committee for periods of one year.

Request from Matt Murphy, Chief of External Affairs, Executive Office of Administration and Finance RE: letter from Select Board recognizing the State Budget item stating "that not less than \$50,000 shall be expended for sewer engineering and interim wastewater management solutions in the Town of Colrain" was intended for the Colrain Sewer District and the Boards desire to see that A&F pay out these funds to the CSD

Kevin Fox explained that the Administration of Finance (A&F) sent a letter to the Board requesting they clarify who the earmark was intended to go to and that the CSD agreed to pay for the 1&1 study with funds from the One-Stop grant in exchange for authorizing A&F to release the \$50,000 to the CSD.

MOVED: Thom Griffin moved to on behalf of the Select Board that we write an email to Rick Mikulis indicating that we recognize that the \$50,000 was intended for the Colrain Sewer District and it is our desire to see us pay out the earmark to the Colrain Sewer District. Further we authorize the Town Administrator to send that email.

Waiver And Release of Right of First Refusal and Assignment Pursuant to M.G.L.c. 61; property located off West Leyden Road identified as Parcel ID 4210-0021-00000

Kevin Fox explained to the Board there is a piece of property on West Leyden Rd that is currently in Chapter 61 and the owners are looking to sell. The Town has the Right of First Refusal, meaning the Town can waive their right or purchase for the accepted offer.

MOVED: Thom Griffin moved to waive the right of first refusal to the parcel of land as identified with Parcel ID 421-0-00210-0000.

Written Information Security Program Approval/Adoption

Every year Kevin meets with Northeast IT, the Town's managed IT service, to identify how the network functions security wise and what we need to do for licensing, software upgrades and capital upgrades. Last year identified the need for a Written Information Security Program, which is required by law and a suggested best business practice and included in the FY24 budget.
