MINUTES OF SELECT BOARD March 12, 2024

Colrain Energy Committee Update

Peter Brooks updated the Board on the completed, in-process and future projects using the Green Communities Grant; insulation at the Highway Garage (completed), lighting and mini-splits at the Town Office (completed), interior storm glazing at the Library (completed), insulation at the Fire Station (in-process), lighting replaced at the elementary school (completed) and air sealing and roof sealing at the school (future). The Committee has increased by two members this year, both with knowledge of solar. They are working on a public presentation on the results of the Solar Action Plan for April. David Greenberg will send information to the Board for review.

New Business:

Review and Possible Approval of Host Community Agreement with Atlantic Farms LLC

Kevin Fox explained that the Host Community Agreement (HCA) with Atlantic Farms has expired and needs to renew. Town Counsel drafted a new agreement and Atlantic submitted revisions today, which have also been sent to Town Counsel. Jackson McCleod commented that Atlantic's revisions pertain to wording regarding the company being indoor cultivation, however, they are licensed to be a Tier 7 Outdoor Cultivator. The Board agreed to revisit the HCA once Town Counsel reviews the suggested revisions from Atlantic Farms.

Nominate Animal Inspector

Kevin Fox explained that the nomination is a hybrid meaning that the Board nominates the Animal Inspector to MDAR (Massachusetts Department of Agricultural Resources), who then appoints the inspector. Ken Shearer is the current Animal Inspector and has agreed to continue should the Board nominate him.

MOVED: Emily Thurber moved to nominate Ken Shearer as the Animal Inspector for the coming year. Thom Griffin seconded. **Approved unanimously.**
